The year 2020 witnessed dark clouds of Global Pandemic (Covid-19) wherein more than 8 crore got infected, around 18 lac lost their lives and millions lost their jobs around the Globe. Many of our colleagues who worked as front line Corona warriors and have been providing uninterrupted services to the clients also lost their lives. We extend our heartfelt condolences to the bereaved families. Bank Management led by Shri Sanjeev Chadha, MD & CEO came forward to enhance death compensation to Rs 50.00 lac. for COVID related deaths, which is un-paralleled in PSBs. It had been, besides other employee care initiatives, to reduce the pains afflicted due to the pandemic. We, on your behalf, made contributions to "PM Care Fund", "CM Relief Funds" and other NGOs and our all Zonal Units directly distributed cooked and raw food items across the country.

We trust all of you are taking due care by following the COVID protocol and nowhere the same is being diluted as "Jab Tak Dawai Nahin - Tab Tak Dhillai Nahin".

We all should appreciate our great scientists who have succeeded in developing vaccine, in such a short time, which has raised hopes that world will get rid of this infectious decease in the NEW YEAR 2021.

On the positive note, the Year 2020 witnessed a successful signing of 11th Bipartite Settlement / 8th Joint Note between UFBU and IBA. Congratulations to all of you for waiting patiently for more than 3 years and helping us to take tough negotiations with IBA - starting from their meager offer of 2% and ultimately settling with 15% increase in wages that too under adverse economic conditions. And as an icing on the cake several other benefits viz. PLI, Enhanced contribution of NPS, Annual Encashment of PL, Hike in Special Allowances and introduction of Learning Allowance and Location Allowance were achieved. There are improvements with respect to stagnation increment in the form of one additional increment up to Scale IV and introduction in Scale V. Periodicity of application of stagnation increment has been reduced from three to two years. We are assured that you will get your arrears before 10th of January 2021.

On organizational front, despite Corona constraints, Association held Structured Meetings at Regional, Zonal and Central level. The Central Level structured meeting was held on 2<sup>nd</sup> September 2020, details of which were circulated vide our Cir No 26 dated 07.09.2020. We kept on addressing General Body Meetings on virtual platform and wherever possible physical meetings across the country. We arranged for Motivational and Stress Free living programmes through virtual methods for our membership. We have organized Orientation Programme for Newly Promoted Officers 2020 on virtual mode on 20th and 27th September 2020. A successful meeting of Lady Officers was also held on 2<sup>nd</sup> October 2020. Friends, from 1st Jan 2020, we took the decision to enhance contribution under ESCORT from Rs.10/to Rs.20/- and accordingly have contributed to the family of deceased. We took another help the family of deceased member by immediate decision from January 2020 to contribution of Rs 50000.00 from our Association Fund. Recently we added two Guest House cum Association Offices - one in Patna and another in Bhopal. We are in the process of acquiring premises at suitable location for establishing Learning Centre for our membership.
